# MyMiltonKeynes Business Against Crime Radio Membership - Terms and Conditions

MyMiltonKeynes Limited supply radio equipment and administration as part of its Business Against Crime Scheme (BAC). MyMiltonKeynes Limited is registered in England and Wales under company number 04260537. Our registered office is Suite 301, Midsummer Place, 417 Saxon Gate East, Milton Keynes, MK9 3GB.

- 1 MyMiltonKeynes Limited shall, upon and subject to the conditions of hire:
- a. Provide the equipment required for membership of the BAC Radio Scheme.
- **b.** Use its best endeavours to maintain the equipment in operating condition and to rectify any defects within a timely manner.
- 2 The Premises detailed on the completed Radio User Agreement (Hirer) shall:
- a. Pay the hire charges together with Value Added Tax (VAT) at the current rate in force annually and in advance.
- b. Use only equipment supplied by MyMiltonKeynes Limited.
- c. Use only approved accessories with the equipment.
- **d.** Comply with any statutes, bye laws or other provisions having the force of law relating to the activities of the Hirer under this agreement and indemnify and keep MyMiltonKeynes Limited indemnified against any claims arising by reason of any breach of any such statute, bye law or other provision.
- e. Not assign this agreement.
- 3 In the event of a continued failure by the Hirer to comply with any regulations issued by HM Government, MyMiltonKeynes Limited may, at its discretion, require the immediate return of all hired equipment.
- 4 MyMiltonKeynes Limited shall not be liable for any loss or damage sustained by the Hirer as a result of any failure of the hired equipment.
- 5 Payments: The Hirer shall pay all charges on or before the due date. In default of payment on the due date, MyMiltonKeynes Limited retains the right to charge interest at 2% over Finance House Base Rate on a day-to-day basis and require the immediate return of the hired equipment.
- 6 All equipment shall remain the property of MyMiltonKeynes Limited and on termination of the hire agreement all equipment must be returned on or before such termination. Additional hire charges will be levied on all equipment not returned by the due date. MyMiltonKeynes Limited reserves the right to charge for repairing and cleaning equipment returned in a damaged, unserviceable or dirty condition.

# **TERMS OF PAYMENT**

- **a.** All payments will be due annually in advance on the anniversary date of the commencement of the hire agreement. An invoice will be raised at the beginning of each period for the purposes of accounting by the Hirer.
- **b.** Parts of the month during which the Hirer retains the equipment will be charged as a full month.

- **c.** In the event that equipment is lost, damaged or destroyed whilst in the possession of the Hirer, rental shall continue to be payable to MyMiltonKeynes in accordance with the forgoing conditions until such time as MyMiltonKeynes Limited receives full payment in respect of such loss, damage pursuant to the Hirers obligations under clause 4 hereof.
- **d.** The Hirer shall notify MyMiltonKeynes Limited in writing immediately of any loss or damage to the equipment and shall on demand reimburse MyMiltonKeynes Limited the full cost of replacing or repairing the equipment.
- e. The Hirer may at any time terminate their MyMiltonKeynes BID Radio Link agreement in writing to MyMiltonKeynes Limited. MyMiltonKeynes Limited reserves the right not to offer refund(s) to the Hirer during the term of the agreement for any reason. The Hirer shall return all equipment issued by MyMiltonKeynes Limited as per the agreement at the point of termination.

### **TYPE OF EQUIPMENT USE**

MyMiltonKeynes Limited reserves the right to change the type of equipment offered as prices and technology change.

### SITUATION OF EQUIPMENT

The Hirer shall not, without the previous consent in writing of MyMiltonKeynes Limited, disable and remove the equipment or any part thereof from the premises stipulated on the application form.

## METHOD OF OPERATION OF EQUIPMENT

- a. The Hirer shall at all times operate the equipment in accordance with such reasonable instructions as MyMiltonKeynes Limited may from time-to-time issue and observe any OFCOM or other regulations issued by HM Government or any state corporation or agency from time-to-time in respect thereof.
- **b.** MyMiltonKeynes Limited will, on occasion, arrange training in the correct and proper use and discipline with respect to the operation of the MyMiltonKeynes BAC Radio scheme. If the Hirer has been found to be consistently misusing the radios or not adhering to the training protocols may be liable to have their equipment removed.
